

# **PSM/RMP Lead Consultant**

#### position summary

In this full-time, exempt position, the Process Safety Management / Risk Management Plan Lead Consultant will lead process hazard analyses (PHAs) and compliance audits pursuant to OSHA's process safety management (PSM) and USEPA's Risk Management Plan (RMP) regulations as well as assist clients with other safety and environmental compliance tasks, as necessary. PSM/RMP and PHA experience is desired.

#### responsibilities
